### Happy Back to School – SLOW DOWN

Children (and parents) are once again walking in the subdivision to and from the bus in the mornings and afternoons. Please

SLOW DOWN as you drive through the neighborhood and be conscientious of our children, neighbors, pets and wildlife!

### **Trails – Use Designated Access Points**

Residents are advised to please access trails right by the TRAIL sign and not take shortcuts. Specifically, this includes the trail by the tennis courts. Please access that trail directly next to the trail marker sign and not use the other short cut trail that is on private property. Be respectful of private property.

## Accessibility of District Utilities and Traffic Signs

Reminder to all residents who have District traffic signs or facilities on an easement on your property, including sewer manholes, water curb stops, and fire hydrants: you must maintain adequate access to these facilities. Manholes, fire hydrants and water valves are not to be covered in landscap-

ing which includes bushes, tree branches, etc.

### **Pond Update**

The District completed the second of two algaecide applications to the pond. There is already improvement from the first one in terms of algae on top of the pond. We continue to look for the best method to attack the type of algae growing from the bottom. We have moved up fire mitigation around the pond to this fall rather than next spring as it is easier to get at some of the vegetation and trees while the water is lower. This will begin the week of September 21. It should also help with reducing water loss next year.

### **Greenbelt Encroachment Prohibited**

This is a reminder to all residents that encroachment on District Greenbelts is prohibited. Adopted by the Board of Directors in 2006, Resolution 2006-04 prohibits the personal use of the District's greenbelts as a means of extending one's own backyard or side yards. For example, no structures (sheds, fences, storage units, etc.) may be placed in the greenbelt; no recreational equipment (trampolines, tree houses, etc.) may be placed in the greenbelt; and no improvements (gardens, plantings, etc.) may be made in the greenbelts. If you have such a structure or equipment on district greenbelt, please remove it before the end of September. There are fines in place for offenders and existing violations are not exempt. ### **Use of Tennis Court**

The District has had several complaints of young people on the tennis court with bikes, scooters, skateboards, etc. Please note that only tennis shoes or sneakers are allowed on the tennis court. Anything else is prohibited including bikes, scooters, skateboards, etc. Please speak with your children and teens about this.



### Save Time, Paper, Postage AND Pay the Last Date Possible

Residents can have their DW2 monthly payment automatically drafted from their bank account each month.

### No Parking – Keep Roads Safe

Parking on District streets is prohibited under Resolution 2004-03, It is a safety hazard as we do not have sidewalks in the subdivision. No one wants to be responsible for someone or someone's pet getting hurt because they parked in the street. It also greatly hinders our maintenance efforts. Please park vehicles including RVs in your private driveways, and remind your guests and neighbors of our policy.

### **Bears and Trash**

Bears are already out and will soon be looking for even more food on their quest to fatten up for winter. Please do not leave birdfeeders or pet food dishes out at night. Do NOT leave your trash can out before the morning of pick-up. Residents must either leave their trash containers in a garage until the day of pick-up and put the container back inside by the end of the day or have a bear-proof garbage container. La Plata County has an ordinance that fines residents at least \$200 for not securing trash containers from wildlife. To report a violation, call the Sheriff's office at 385-2900. Check out bearsmartdurango.org for more resources. Bear Smart Durango is urging residents to use excess fruit instead of leaving it on or under trees. Although household trash is the primary source of local bear/human conflicts, unused ripened fruit is another. Extra fruit can be used for livestock feed, human consumption and composting. An additional benefit of using all available fruit is a reduced likelihood of tree damage by bears.
